OFFICE ORDER

Sub: Lockdown of Bengaluru area comprising of BBMP area, Bengaluru Urban District and Bengaluru Rural District with effect from 08.00Pm of 14.07.2020 to 05.00 Am of 22.07.2020.

Ref: Government of Karnataka order in F.No.RD158 TNR 2020 dated 13.07.2020.

Consequent to the surge of COVID-19 in the recent past in Bengaluru. The Chief Secretary and Chairman of State Executive Committee, Karnataka State Disaster Management Authority Vide Order No RD 158 TNR 2020 dated 13.07.2020 has passed an order of lock down in Bengaluru area (Comprising BBMP, Bengaluru Urban District and Bengaluru Rural district) In order to contain the spread of COVID-19 in Bengaluru, **with effect from 8.00 PM of 14th July 2020 to till 5.00 AM of 22nd July 2020.** Further, directing all the Heads of the Department that they shall implement the measures as enumerated in the guidelines annexed to the above order.

2. In view of the above order of the Chief Secretary and Chairman of State Executive Committee, Karnataka State Disaster Management Authority dated 13/07/2020, the Pr.Chief Commissioner of Income-tax, Karnataka & Goa Region hereby orders that:

- a) The Office order vide F.No.Pr. CCIT/COVID-19/2019-20 dated 06th July 2020 issued by this office is kept in abeyance for the offices located in Bengaluru with effect from 8.00 PM of 14th July 2020 to till 5.00 AM of 22nd July 2020.
- b) The Officers/Officials **shall work from home and should be available on telephone and electronic means of communication.**
- c) The CCsIT/Pr.CsIT/Pr.DsIT/CsIT/DsIT/ Head of the Department/ Head of Offices shall ensure that Treasury functions (As listed in Para 3(c) of the Government of Karnataka order dated 13.07.2020) such as pay and allowances (DDO Function) and preparation of all essential bills and submission to ZAO shall not be hampered. Adequate transport arrangement for such officers and Officials shall be made.

d) Further, any Orders/Guidelines/Circulars/OM issued with regard to COVID-19 subsequent to this order by Government of India, concerned state Government/Concerned Local Administration will supersede this order and all the Officers/Officials have to follow the Orders/guidelines/Circulars/OM accordingly.

3. The Income-tax Offices located in the Districts of State of Karnataka excluding the Bengaluru area (Comprising BBMP, Bengaluru Urban District and Bengaluru Rural district) will function as per this office order dated 06.07.2020.

4. However, the Income tax Office located in the state of Goa will continue to function as per this Office Order Vide F.No.PrCCIT/COVID-19/2019-20 dated 06th July 2020 issued by this office. HOD in state of Goa should adhere to the local Authority Guidelines or Orders.

5. This issues with the approval of Pr.Chief Commissioner of Income-tax, Karnataka & Goa Region, Bengaluru.
