**NOTIFICATION FOR RECRUITMENT OF MERITORIOUS SPORTS PERSONS IN THE  
CADRE OF INSPECTOR OF INCOME TAX, TAX ASSISTANT AND MULTI-TASKING  
STAFF – 2022-23**

The Principal Chief Commissioner of Income-Tax, Karnataka and Goa Region invites applications from meritorious sports persons for appointment as Inspector of Income Tax, Tax Assistant and Multi-Tasking Staff. Before making an application, the applicants are required to go through the detailed guidelines, eligibility criteria, vacancy position, other conditions and instructions for the direct recruitment given below to ascertain their eligibility for the post.

**Note:** Candidate can apply for the post(s) of Inspector of Income Tax or Tax Assistant or Multi-Tasking Staff or for all above posts in a single application.

**4. SELECTION CRITERIA:** The meritorious sportspersons will be considered for appointment based on the following criteria.

**4.1 Order of Preference:** Meritorious sportspersons will be selected as per the order of preference contained in the DoPT OM No. 14034/1/95-Estt. (D) dated 04.05.1995 and as mentioned in the consolidated instruction issued by the DoPT vide OM No. 14034/01/2013-Estt (D) dated 03.10.2013. The order of preference prescribed by the Department of Personnel & Training in this regard is as under:

- A) First preference:** to those candidates who have represented the country in International Competition with the clearance of the Department of Youth Affairs and Sports.
- B) Second preference:** to those who have represented a State/Union Territory in the Senior or Junior Level national championships organized by the National Sports Federations recognized by the Department of Youth Affairs & Sports or National Games organized by Indian Olympics Association *and* have won medals or positions up to 3<sup>rd</sup> place. Between the candidates participating in senior and Junior National Championships/games, the candidates having participated *and* won the medal in Senior National Championship shall be given preference.
- C) Third preference:** to those, who have represented a University in an Inter-University competition conducted by the Association of Indian Universities / Inter-University Sports Board *and* have won medals or positions up to 3<sup>rd</sup> place in finals.
- D) Fourth preference:** to those, who have represented the State Schools in the National Sports/Games for Schools conducted by the All-India School Games Federation *and* have won medals or positions up to 3<sup>rd</sup> place.
- E) Fifth preference:** to those, who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.
- F) Sixth preference:** to those who represented a State / Union Territory / University / State School Teams at the level mentioned in categories (B) to (D) but could not win a medal or position, in the same order of preference.

**Note 1.** In the event of tie between two candidates, tie-breaker rules as per guidelines shall be applicable.

**Note 2.** In case of any doubt about the status of a tournament/event, the matter will be decided by the Pr. Chief Commissioner of Income Tax, Karnataka and Goa Region.

**7.1 Nationality/Citizenship:** A candidate must be a citizen of India.

**7.3 Relaxation of Age:** As per Government of India instructions for meritorious sportspersons, relaxation of upper age limit up to a maximum of 5 years (10 years in case of SC/ST candidates) may be allowed for the purpose of appointment in Group 'C' cadres.

**Note:** This relaxation will be admissible only to those sports person who satisfies all other eligibility conditions related to education and sports qualifications and furnish a certificate in the form and from an authority prescribed in this instruction.

**8. EXAMINATION:** The candidates will be shortlisted based on their achievements in sports by the O/o Pr. Chief Commissioner of Income Tax, Karnataka and Goa Region. Only the shortlisted candidates will be called to appear in the examination.

**8.1 Scheme of Examination:** The written examination will consist of One paper (Paper- I) as shown below:

**8.2 Indicative Syllabus:**

**A. General Intelligence & Reasoning:** It would include questions of both verbal and non-verbal types. This component may include questions on analogies, similarities and differences, space visualization, spatial orientation, problem-solving, analysis, judgment, decision-making, visual memory, discrimination, observation, relationship concepts, arithmetical reasoning and figural classification, arithmetic number series, non-verbal series, coding and decoding, statement conclusion, syllogistic reasoning, etc. The topics are, Semantic Analogy, Symbolic/Number Analogy, Figural Analogy, Semantic Classification, Symbolic/Number



Classification, Figural Classification, Semantic Series, Number Series, Figural Series, Problem Solving, Word Building, Coding & de-coding, Numerical Operations, symbolic Operations, Trends, Space Orientation, Space Visualization, Venn Diagrams, Drawing inferences, Punched hole/ pattern- folding& un-folding, Figural Pattern-folding and completion, Indexing, Address matching, Date & city matching, Classification of centre codes/roll numbers, Small & Capital letters/numbers coding, decoding and classification, Embedded Figures, Critical thinking, Emotional Intelligence, Social Intelligence.

- B. General Awareness:** Questions in this component will be aimed at testing the candidates' general awareness of the environment around him and its application to society. Questions will also be designed to test knowledge of current events and of such matters of everyday observations and experience in their scientific aspect as may be expected of any educated person. The test will also include questions relating to India and its neighbouring countries especially pertaining to History, Culture, Geography, Economics, General Policy & Scientific Research.
- C. Quantitative Aptitude:** The questions will be designed to test the ability of appropriate use of numbers and number sense of the candidate. The scope of the test will be the computation of whole numbers, decimals, fractions and relationships between numbers and Percentages, Ratio & Proportion, Square roots, Averages, Interest, Profit and Loss, Discount, Partnership Business, Mixture and Alligation, Time and distance, Time & Work, Basic algebraic identities of School Algebra & Elementary surds, Graphs of Linear Equations, Triangle and its various kinds of centers, Congruence and similarity of triangles, Circle and its chords, tangents, angles subtended by chords of a circle, common tangents to two or more circles, Triangle, Quadrilaterals, Regular Polygons, Circle, Right Prism, Right Circular Cone, Right Circular Cylinder, Sphere, Hemispheres, Rectangular Parallelepiped, Regular Right Pyramid with triangular or square base, Trigonometric ratio, Degree and Radian Measures, Standard Identities, Complementary angles, Heights and Distances, Histogram, Frequency polygon, Bar diagram & Pie chart.
- D. English Language and Comprehension:** Candidates' ability to understand correct English, his basic comprehension and writing ability, etc. would be tested. Vocabulary, grammar, sentence structure, synonyms, antonyms and their correct usage; Spot the Error, Fill in the Blanks, Synonyms/ Homonyms, Antonyms, Spellings/ Detecting mis-spelt words, Idioms & Phrases, One word substitution, Improvement of Sentences, Active/ Passive Voice of Verbs, Conversion into Direct/ Indirect narration, Shuffling of Sentence parts, Shuffling of Sentences in a passage, Cloze Passage, Comprehension Passage. To test comprehension, three or more paragraphs will be given and questions based on those will be asked. At least one paragraph should be a simple one based on a book, or a story and the other two paragraphs should be on current affairs, based on a report or an editorial.

**E. Computer Proficiency:** Computer Basics: Organization of a computer, Central Processing Unit (CPU), input/ output devices, computer memory, memory organization, back- up devices, PORTs, Windows Explorer. Keyboard shortcuts. Software: Windows Operating system including basics of Microsoft Office like MS word, MS Excel and Power Point etc. Working with Internet and e-mails: Web Browsing & Searching, Downloading & Uploading, Managing an E-mail Account, e-Banking.

**Note 1:** The questions will be of such level to assess the basic minimum proficiency of the candidate to be suitable to post applied.

**Note 2:** The examination is purely qualifying in nature. A candidate needs to score a minimum of 100 marks (40% of the total marks) for qualification.

**Note 3:** The detailed schedule of the examination including date, time, and venue will be informed to candidates only through <https://www.incometaxbengaluru.org/>.

### **8.3 Admission to the Examination:**

- The names of the candidates who are shortlisted based on their achievements in the sports will be uploaded on <https://www.incometaxbengaluru.org/> two weeks before the date of the examination.
- The candidates who are shortlisted based on their achievements in the sports, will be assigned Roll numbers and issued Admission Certificates (AC) by post and e-mail by the O/o Pr. Chief Commissioner of Income Tax, Karnataka and Goa Region, Bengaluru for appearing in the examination.
- Candidate must bring the Admission Certificate to the Examination Hall.
- In addition to the Admission Certificate, it is mandatory to carry at least one Original Valid Photo-ID proof having the Date of Birth as printed on the Admission Certificate, such as:
  1. Aadhaar Card / Printout of E-Aadhaar,
  2. Voter's ID Card,
  3. Driving License,
  4. PAN Card,
  5. Passport,
  6. Employer ID Card (Govt./ PSU),
  7. Ex-Serviceman Discharge Book issued by the Ministry of Defense,
  8. Any other photo-bearing ID Card issued by the Central/ State Government.
- If Photo Identity Card does not have the date of birth printed on it then the candidate must carry an additional original document (e.g., Matriculation Certificate, Marks Sheet issued only by CBSE/ ICSE/ State Boards; Birth Certificate, Category Certificate) in proof of their date of birth. In case of a mismatch in the date of birth mentioned in the Admission Certificate and photo ID/ Certificate brought in support of the date of birth, the candidate will not be allowed to appear in the examination.
- Any other document mentioned in the Admission Certificate shall also be carried by the candidates while appearing in the Examination.



#### **8.4 Provision of Compensatory Time and assistance of scribe:**

- In the case of persons with benchmark disabilities in the category of blindness, locomotor disability (both arms affected-BA), and cerebral palsy, the facility of a scribe is provided, if desired by the candidate.
- In the case of the remaining categories of persons with benchmark disabilities, the provision of scribe will be provided on production of a certificate at the time of examination to the effect that the person concerned has physical limitations to write, and a scribe is essential to write the examination on his/her behalf, from the Chief Medical Officer/ Civil Surgeon/ Medical Superintendent of a Government health care institution as per Proforma at *Annexure-D*.
- The facility of scribes will be provided to the PwBD candidates only if he/she has opted for the same in the online application form.
- The candidate will have the discretion of opting for his/her own scribe or to avail the facility of a scribe provided by this office. Appropriate choice in this regard will have to be given by the candidate in the application form.
- In case the candidate opts for his/her own scribe, the qualification of the scribe should be one step below the qualification of the candidate taking the examination. The candidates with benchmark disabilities opting for their own scribe shall be required to submit details of their own scribe at the time of examination as per the Proforma in *Annexure-E*. In addition, the scribe has to produce valid ID proof (Aadhaar Card / Printout of E-Aadhaar / Voter's ID Card / Driving License / PAN Card / Passport) in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will be submitted along with Proforma in *Annexure-E*. If subsequently it is found that the qualification of the scribe is not as declared by the candidate, then the candidate shall forfeit his/her right to the post and claims relating thereto.
- A compensatory time of 20 minutes per hour of examination will be provided to the persons who are allowed the use of a scribe.
- The candidates who are eligible for use of a scribe but not availing of the facility of a scribe will also be given compensatory time of 20 minutes per hour of examination. The PwBD candidates who wish to avail of compensatory time must produce a certificate as per Proforma in *Annexure-D* at the time of examination.
- No attendant other than the scribe for eligible candidates will be allowed inside the Examination Hall.
- One-eyed candidates and partially blind candidates who are able to read the normal Question Paper set with or without a magnifying glass and who wish to write/ indicate the answer with the help of magnifying glass will be allowed to use the same in the Examination Hall and will not be entitled to a scribe. Such candidates will have to bring their own magnifying glasses to the Examination Hall.

#### **9. HOW TO APPLY:**

1. For detailed instructions, please refer to the Notification Dated 06.02.2023 for the "Recruitment of Meritorious Sports Persons in The Cadre of Inspector of Income Tax,

Tax Assistant and Multi-Tasking Staff – 2022-23” issued by Pr. Chief Commissioner of Income Tax, Karnataka and Goa, Bengaluru. The applicant has to go through the notification, instructions to candidates, vacancy positions, etc. carefully before filling up the application form.

2. The application form as provided in the Notification must be filled completely and signed. The candidates are required to submit the signed application form in original along with attested copies of the necessary documents. The application form so filled should be sent by speed post or registered post to the address: “**Commissioner of Income Tax (Admin and TPS), O/o Principal Chief Commissioner of Income-Tax, Karnataka and Goa Region, Central Revenue Building, No.1, Queen’s Road, Bengaluru, Karnataka-560001**” so as to reach this office on or before 24.03.2023, the last date fixed for the receipt of the application.
3. Only one application should be submitted by the candidate.
4. The application envelopes should be superscribed as - “**APPLICATION FOR THE POST OF INSPECTOR OF INCOME TAX/TAX ASSISTANT/ MULTI TASKING STAFF – 2022-23 UNDER MERITORIOUS SPORTS QUOTA**”  
**NAME OF THE SPORT: -**
5. The application should be sent through Speed Post/Registered Post only. Those sent through other means viz. private couriers, by hand etc. shall not be accepted.
6. One envelope should contain one application form only.
7. Original certificates should not be sent with the application form, only the Self-attested copies of all the required documents and certificates should be sent along with the application.
8. Self-attested copies of the following documents should invariably accompany the signed application form: -
  - i. 10<sup>th</sup> Std. or Matriculation marksheet / certificate
  - ii. 12<sup>th</sup> Std. marksheet / certificate
  - iii. Graduation, Post-graduation certificate/s.
  - iv. Certificates on Eligibility for Recruitment of Sportsperson (Form- 1,2,3,4 and 5)
  - v. Best performance proof and/or Latest performance.
  - vi. Community/Caste Certificate, if any.
  - vii. Certificate of PwBD, if applicable
  - viii. Ex-Serviceman Discharge Book issued by the Ministry of Defense
9. In the Application Form, candidates are required to affix the latest color passport-size photograph in the space provided. The photograph should not be more than three months old from the date of publication of this notification.
10. The photograph should be without a cap and the frontal view of the face should be clearly visible.
11. Additionally, two latest (not more than three months old from the date of notification) colour passport size photographs, shall be pinned to the application form. The photographs should be without cap and the frontal view of the face should be clearly



visible. If the proper photograph is not furnished with the application by a candidate, his/her candidature will be cancelled.

12. Candidates are advised in their own interest to submit the application much before the closing date and not to wait till the last date. The O/o Pr. Chief Commissioner of Income Tax, Karnataka and Goa Region, Bengaluru will not be responsible for the candidates not being able to submit their applications within the last date on account of any reason beyond the control of this office.
13. In the event of any clarification with respect to filing of application, the candidates may communicate to [bangalore.ito.hq.pers.trg@incometax.gov.in](mailto:bangalore.ito.hq.pers.trg@incometax.gov.in).

#### **10. APPLICATION FEE:**

1. Fee payable: ₹100/- (Rs one hundred only).
2. Women candidates and candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST), Persons with Benchmark Disabilities (PwBD), and Ex-servicemen are exempted from payment of fee.
3. Fee can be paid through Postal Order or Demand Draft from any nationalized bank drawn in favour of "ZAO, CBDT, Bangalore". The postal order / Demand Draft needs to be attached with the signed copy of the application.
4. Applications received without payment of the requisite fee will be treated as INCOMPLETE and summarily rejected. No request for consideration of such applications will be entertained.
5. Fee once paid shall not be refunded under any circumstances.

#### **11. INSTRUCTIONS TO THE APPLICANTS:**

1. The applicant has to go through the notification, instructions to candidates, vacancy positions etc. carefully before filling up the application form.
2. If the prescribed/required documents are not submitted along with the application, the application so received will be rejected and no request for revival will be considered. The documents/marks lists/certificates submitted at a later date will not be entertained.
3. Applications received complete in all respects will only be considered. Applications submitted prior to this notification and after the last date prescribed for submitting the application will not be considered under any circumstances. Incomplete, unsigned applications or applications without the required Annexures will be summarily rejected and no correspondence in the matter will be made with the applicant.
4. Caste certificates for SC/ST and OBC in the prescribed form (Prescribed for appointment under the Government of India) from the competent authorities as in *Annexure-B and C* respectively are to be submitted. Candidates seeking relaxation benefits must ensure that they are entitled to such relaxation as per the eligibility prescribed in the Notification. They should also be in possession of the certificates in the prescribed format in support of their claim.

5. Candidates with benchmark disabilities will be considered as Persons with Disabilities (PwD) and entitled to relaxation for Persons with Disabilities.
6. The format and the competent authorities are prescribed for issuing the certificates of sports achievement. The certificates of sports achievements submitted in any other form or from authorities not competent to issue the same will be ignored.
7. The selected candidates should produce relevant original certificates only at the time when it is called for.
8. The candidate on appointment will be liable for posting at any place in the Karnataka & Goa Region and he/she shall not apply for Inter-Charge Transfer / Transfer on a loan basis to another region. A declaration to this effect should be submitted by the applicant in the application.
9. Sports persons who are already employed in Central Government or State Government or PSU should furnish NOC from the present employer.
10. The Pr. Chief Commissioner of Income Tax, Karnataka and Goa Region, Bengaluru reserves the right either to revise the number of vacancies or to cancel the recruitment, so warranted and will not be liable to return the fee or pay any compensation on the applicant's application.
11. Failure to comply with the instructions/conditions prescribed in the notification will result in the rejection of the application and no intimation will be served. No communication in this regard will be entertained.
12. Any form of canvassing/bringing undue pressure by any candidate will render his / her candidature liable to be rejected summarily at any stage of the recruitment process.
13. The applicants are advised to visit [www.incometaxbengaluru.org](http://www.incometaxbengaluru.org) from time to time for more details and Information.
14. The candidates selected will be appointed and will be on probation as per the rules. The training will be imparted to the selected candidates as prescribed.
