OFFICE ORDER / कार्यालय आदेश

Sub: Lockdown of Dakshina Kannada District with effect from 8.00 PM of 15-07-2020 to 05.00 AM of 23-07-2020

Ref: Deputy Commissioner & District Magistrate, Govt. of Karnataka, Dakshina Kannada, Mangaluru Order in No. CAL.CR 22/2020/88613/C1, dated 14-07-2020.

Consequent to the surge of COVID-19 in the recent past in Dakshina Kannada District of Karnataka State, the Deputy Commissioner and District Magistrate, Govt. of Karnataka, Dakshina Kannada, Mangaluru vide Order No. CAL.CR 22/2020/ 88613/C1, dated 14-07-2020, has passed an order of Lockdown in Dakshina Kannada District in order to contain the spread of COVID-19 in the district with effect from 8.00 PM of 15-07-2020 to 05.00 AM of 23-07-2020, further directing all the Heads of the Department that they shall implement the measures as enumerated in the Guidelines annexed to the above order. As per Para 3 of the said Order, all Central Government offices are to be kept closed.

2. In view of the above order of the Deputy Commissioner and District Magistrate, Govt. of Karnataka, Dakshina Kannada, Mangaluru dated 14-07-2020, the undersigned orders that:


a) The Office Order vide F.No:Estt/Covid-19/Pr.CIT/MNG/2020-21, dated 07-07-2020, issued by this office is kept in abeyance for the offices located in Dakshina Kannada District (i.e. Mangaluru and Puttur IT Offices) with effect from 8.00 PM of 15-07-2020 to 05.00 AM of 23-07-2020.

b) The Officers/Officials of Mangaluru and Puttur office **shall work from home and should be available on telephone and electronic means of Communication.**

c) The Heads of Offices shall ensure that Treasury functions (As listed in Para 3(c) of the Govt. of Karnataka Order dated 14-07-2020) such as Pay and Allowances (DDO function) and preparation of all essential Bills and submission to FPU/ZAO shall not be hampered. Adequate transport arrangement for such officers and officials shall be made.

d) Further, any Orders/Guidelines/Circulars/OM issued with regard to COVID-19 subsequent to this order by Govt. of India, concerned State Govt./Concerned Local Administration will supercede this order and all the Officers/Officials have to follow the Orders/Guidelines/Circulars/OM accordingly.

3. The Income Tax Offices located in the Districts of Udupi (IT Office, Udupi) and Uttar Kannada (IT Office, Karwar) will function as per this office order dated 07-07-2020.
