No. 35034/3/2008-Estt.(D) dated 19th May, 2009 read with clarifications issued by DOPT and Board from time to time wherein the financial benefit allowed under ACP/MACP Scheme shall become final and no pay fixation benefit accrue at the time of promotion i.e. posting against a financial post in the higher grade.

This promotion order is issued purely on temporary basis and the official(s) are liable for reversion at any time without assigning any reasons, if after a review of vacancies it is found that his/her appointment is in excess of the vacancies available OR for any other reasons, including directions of any Court/CBDT/DoPT etc.
