In terms of letters dated 14/09/2009 & 06/03/2012 issued by the Director of Income Tax (HRD), CBDT, New Delhi wherein ITO/SPS/AO Gr-II on completion of regular service of 4 years in grade pay of Rs.4800/- in PB-2 shall be granted the grade pay of Rs.5400/- in PB-2/higher level of Pay (Level 9) on non-functional basis provided they are **free from vigilance angle**.
