No. 35034/3/2008-Estt.(D) dated 19th May, 2009 read with clarifications issued by DOPT and Board from time to time wherein the financial benefit allowed under ACP/MACP Scheme shall become final and no pay fixation benefit accrue at the time of promotion i.e. posting against a financial post in the higher grade.
- 3. This promotion order is issued purely on temporary basis and the officers(s) are liable for reversion at any time without assigning any reasons, if after a review of vacancies it is found that his/her appointment is in excess of the vacancies available OR for any other reasons, including directions of any Court/CBDT/DoPT etc.
- 4. The promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter related to SLP(C) No.30621/2011 and 31288/2017 & orders of

litigations pending in various courts and further instructions of DOPT and/or CBDT in this regard.
