2. The financial upgradation granted above is strictly subject to conditions stipulated in DoPT OM.No. 35034/3/2008-Estt.(D) dated 19/05/2009 & DoPT OM.No. 35034/3/2015-Estt(d) dated 22/10/2019 and all other clarifications received from time to time.

3. As per the DoPT OM No.35034/3/2008-Estt.(D) dtd. 09.09.2010 (clarification No.11), the pay of such Gr.D employees who have been placed in the Grade Pay of Rs.1800/- w.e.f. 01.01.2006 shall be fixed successively in the next three immediate higher grade pays in the hierarchy of revised pay-bands and grade pays allowing the benefit of 3% pay fixation at every stage. The same is also applicable for all the MACP beneficiaries as per para 22 of DoPT O.M.No. 35034/3/2008-Estt. (D) dtd. 19.05.2009. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion, if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available to the Government servant.


4. As per the DoPT OM DoPT OM.No. 35034/3/2015-Estt(d) dated 22/10/2019, benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial upgradation under the Scheme (as prescribed in Para-13 of CCS(Revised Pay Rules), 2016. There shall however, be no further fixation of pay at the time of regular promotion if it is in the same pay level as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher pay level than what is available under MACPS, then he/she shall be placed in the level to which he is promoted at a cell in the

promoted level equal to the figure being drawn by him on account of MACP. If no such cell is available in the level to which promoted, he shall be placed at the next higher cell in that level. The employee may have an option to get this fixation done on the date of promotion or w.e.f. the date of next increment as per the option exercised by him/her.

5. The grant of financial upgradation under MACPS contemplates merely placement on personal basis in the immediate higher Grade Pay/Pay Level/grant of financial benefits only and does not amount to actual/functional promotion. The officials who are granted financial upgradation under the MACP Scheme shall continue to function in their present offices of posting.

6. This issues with the approval of the Pr.CCIT, Bengaluru.
