Sub : Re-joining the post of Stenographer Grade-I in Income Tax Department, Karnataka & Goa Region on lien – No Objection – Shri Gaurav Chandra – regarding –

Shri Gaurav Chandra (DOB :07/05/1991) had joined the Income Tax Department, Karnataka & Goa Region as Stenographer Grade-II (Level-4) on 09/08/2017. He was promoted to the rank of Stenographer Grade-I(Level-6) on 01/12/2022. Consequent upon selection to the post of Stenographer Grade-II in National Sample Survey Office, Field Operations Division, Govt. of India, New Delhi through the SSC Stenographer Grade "C" & "D" Examination – 2023, the official tendered technical resignation (with lien) from the post of Stenographer Grade-I vide letter dated 25/04/2024. The technical resignation (with lien) of Shri Gaurav Chandra was accepted by the Competent Authority and he was relieved on 21/05/2024 by the Commissioner of Income Tax (Appeals)-15, Bengaluru vide Order in F.No. Est/CIT(A)-15/BNG/2024-25 dated 21/05/2024. Thereafter, the official reported for duty in post of Stenographer Grade-II at National Sample Survey Office (Field Operations Division), Regional Office, Jammu on 22/05/2024.

2. The official vide his letter dated 10/02/2025 has submitted his request for re-joining the post of Stenographer Grade-I in Income Tax Department, Karnataka & Goa Region, citing certain domestic and unavoidable circumstances. The request of the official was forwarded to this office by the O/o National Statistics Office, Delhi vide letter cited under reference (2) above.

3. As per this office records, Shri Gaurav Chandra holds lien on the post of Stenographer Grade-I (Level-6) in Income Tax Department, Karnataka & Goa Region for a period of 2 years i.e. upto 21/05/2026. Accordingly, the Competent Authority has approved the request of Shri Gaurav Chandra for re-joining the post of Stenographer Grade-I (Level-6) in Income Tax Department, Karnataka & Goa Region subject to the following conditions :-

- i. The period spent by the Government servant in another department which he had joined after submitting his technical resignation will not count for minimum qualifying service for promotion in the higher post.
- ii. Seniority in the post held by the Government servant on substantive basis continues to be protected.
- iii. Any other conditions as laid down by the DoPT from time to time.

4. On repatriation, Shri Gaurav Chandra is posted in the **O/o Commissioner of Income Tax (Exemptions), Unity Building, P. Kalinga Rao Road, Bengaluru-560027** with advice to join **on or before 30/06/2025**.

5. This issues with the approval of the Principal Chief Commissioner of Income Tax, Karnataka & Goa Region, Bengaluru.
