In terms of DOPT's OM No. AB-14017/8/2010-Estt.(RR) dated 10/03/2010 & CBDT's clarification in letter F.No. A-12018/9/2011-Ad.VII dated 07/09/2011, it has been decided that the posts of Stenographer Grade-I and Stenographer Grade-II be merged and re-designated as Stenographer Grade-I and the post of Stenographer Grade-II(DR) (previously Stenographer Grade-III) be re-designated as Stenographer Grade-II.
