in exercise of the powers conferred by section 120 of the Income-tax Act, 1961(43 of 1961) and in accordance with Notification in S.O. No. 2752(E) dated 22nd October, 2014 of Government of India, Central Board of Direct Taxes, New Delhi published in the Gazette of India, Extraordinary, Part-II, Section 3(ii) dated 22nd October, 2014 [Notification No.50/2014 in F.No. 187/38/2017(ITA.I)], Notification No.64/2014 in F.No.187/40/2014 (ITA-I) dated 13.11.2014 and other Notifications /Orders /Communications of the Central Board of Direct Taxes, New Delhi in this regard,
the Principal Chief Commissioner of Income-tax, Karnataka & Goa Region, Bengaluru hereby amend the Order notified in F.No. 169/Pr.CC/Tech/Cadre Restructure Matters/2014-15 dated 15th November, 2014 and



in supersession of all restructuring Orders issued by this office in respect of the jurisdiction related to Range/Circle/Ward of Karnataka & Goa Region until 12th August, 2020, the Charges mentioned herein only and the posts mentioned in Column (4) of Schedule-1 are merged/diverted as under:

- a) the post of the Additional/Joint Commissioner of Income-tax, Additional/Joint Director of Income-tax is merged with the corresponding post as mentioned in Column (2) of the Schedule-1 annexed hereto;
- b) the post of the Deputy/ Assistant Commissioner of Income-tax, Deputy/ Assistant Director of Income-tax is merged with the corresponding post as mentioned in Column (3) of the Schedule-1 annexed hereto; and
- c) the post of the Income-tax Officer/Tax Recovery Officer is merged with the corresponding post as mentioned in Column (3) of the said Schedule-1 annexed hereto;

having their headquarters mentioned along with post, within the charges of the Principal Chief Commissioner of Income-tax, Bengaluru; Chief Commissioner of Income-tax, Bengaluru-1 and Principal Commissioners of Income-tax/Commissioners of Income-tax/ Principal Directors of Income-tax / Directors of Income-tax in Karnataka and Goa Region, Bengaluru.

2. This Order shall be deemed to have come into force with effect from the 13th August, 2020.

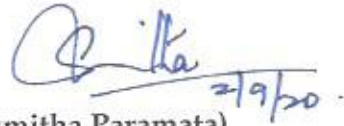
