
The O/o ITAT, Bengaluru is in the process of disposing scrap items. The details of the goods being disposed of are as follows:

ANNEXURE 'A'
TERMS AND CONDITIONS

Access to the scrap and inspection will be allowed under supervision of Department personnel only.

B. No request for inspection after submission of offer will be accepted.

1. Bids only in sealed envelope will be accepted. Bids received in email will not be accepted.
2. ITR, GSTIN details of the bidder should be submitted along with the quotation.
3. Bid quotation should be dropped in the designated box placed in the **Room No. 4**.
4. EMD of Rs. 100/- in the demand draft favoring **ZAO, CBDT, Bengaluru** should be submitted along with the bid documents.
5. The **reserve price of Rs. 44,000/-** is fixed for the scrap items. Bid below the reserve price will be rejected.
6. The vendor must obtain an acknowledgement from the Department for having submitted his/her proposal for bid.
7. The Department reserves the right to accept or reject any or all the proposals without assigning any reason. In case of any tie among bidders, Department reserve right to come up with solution to break the tie and accordingly decide the award of the bid.
8. While appearing in the bid opening session, the acknowledgement receipt given by the department should be compulsorily produced.
9. The highest quotation for purchaser of the scrap will be given the tender.
10. The successful bidder is required to submit the demand draft of the bid amount favoring **ZAO, CBDT, Bengaluru** on or before **29.02.2024**
11. Subsequently, the Goods must be lifted within 4 working days from the date of confirmation of the disposal by the Office of the Commissioner of Income Tax(DR)(ITAT)-2, Bengaluru.
12. In case the vendor with highest offer fails to honour the tender terms and conditions, then the vendor with second highest proposal will be allowed to lift the scrap goods.
13. The cost of lifting of old items shall be borne by the tenderer. The Department takes no responsibility in this regard.
14. The Department reserves the right to deduct any expenses, loss/claims on account of the failure of the vendor to comply with the terms and conditions.
