- 4. The proposed work contract includes creation of furniture and fixtures for the office of Commissioner of Income Tax (Exemptions), 6th Floor, East wing and West Wing, Unity Building Annexe, Kalinga Rao Road, Bengaluru as per **Annexure-V**.
- 5. A proposed design by the bidder is to be submitted as part of the technical bid. The proposed design should be functional and conform to sound engineering principles while maintaining refreshing aesthetics. The design should be open and seamless for common areas with sufficient natural light while minimizing outside ambient noise.
- 6. Interested parties may inspect the proposed renovation site from 31/08/2023 to 08/09/2023 on all working days from 11.00 am to 4.30 pm.

#### **BIDDER'S INSTRUCTIONS**

- This tender is a three-stage sequential evaluation-based-qualification bid consisting of a 'Pre-Qualification Bid', 'Technical bid' and 'Financial bid'. Every tender should be submitted with Pre-qualification Bid, Technical bid and financial bid separately in sealed covers.
- 2. The relevant details which relate to Pre-Qualification Bid are given in Annexure-I.
- 3. The relevant details of Technical Bid Document (Annexure-II), methodology of Evaluation criteria for Technical Bid is outlined in Annexure-III and Financial Bid as per Annexure-IV.

#### **BID IS IN TWO PARTS.**

- (i) Technical Bid containing details of general nature viz. Demand Draft for Cost of bid document, E.M.D., details required for Eligibility Criteria, Experience of Bidder as asked for in the bid. (as per the relevant Annexure)
- (ii) Financial Bid shall contain Schedule of rates duly filled, signed and stamped on each page. (as per the relevant Annexure)
  - The above two envelopes should be separately sealed and superscripted as "Envelope No.1-Technical Bid" and as "Envelope No.2-Financial Bid" and enclosed in a larger Envelope super scribing as 'Techno-Financial Bid' with Tender Notice No., description of work and due date of opening on the cover and addressed to the Commissioner of Income Tax (exemptions), Bengaluru.
- (iii) Financial bid of only those bidders whose technical bids are found acceptable, in order and complete in all respects shall be opened by constituted committee in this office on notified time, date and place in presence of Qualified bidders or their duly nominated representatives. Financial bid of bidders who do not qualify as per contents of the technical bid shall be returned to them along with their E.M.D. and Financial bid (without opening).
- (iv) The Department reserves the right to reject any bid without assigning any reasons thereof, in the interest of the work.
- (v) Any deviation from the clauses hidden/intentional/unintentional shall be considered as contravention of the clauses of Bid document and same shall also be grounds of rejection.
- 4. Only those tenders who qualify Pre-qualification Bid will proceed to evaluation stage in Technical Bid. Incomplete tenders and those which do not conform to the regulations set in Pre-qualification stage will be rejected and their Technical Bid will not be considered for evaluation.
- 5. Financial bid of only those tenders which achieve 75% or more in the Technical Bid evaluation will be opened. The other remaining which does not achieve 75% will be deemed to have been rejected.
- 6. The lowest value bid received amongst the financial bids will be termed as L1 and work contract will be awarded to the said contractor. The said L1 contractor to abide by terms and conditions as outlined below and complete scope of work and minimum specification requirements are as per Annexure-V.

- 7. The Lowest quote shall be considered as L1 and shall be further considered for award of the work contract. The lowest bid L1 will be termed the contractor and work contract awarded accordingly subject to terms and conditions. However, in case of failure of L1 to adhere to terms and conditions of this contract, the next bidder will be given the work contract at the rates quoted by the L1 bidder
- 8. The aggregate annual business turnover of the contractor in the last three financial years should be more than Rs. 4.00 Crore and minimum of Rs.1 Crore and above turnover in all the three previous years. Certified financial statements should be enclosed for evidence. Copies of the IT Return filed for the latest three Financial Year should be furnished along with a certified copy of the PAN card to be enclosed with prequalification bid.
- 9. Each bidding contractor should have a minimum of five (05) years' experience in the field of creation of office space/Work station and he should have executed 3-4 projects in renovation/creation of office spaces work in Central Government Department. Necessary evidence of execution of office space/work station should be enclosed with the Pre-qualification bid document. Copies of work order, completion certificates, and pictures of the completed work showing the complexity of design should be submitted. The design submitted in the pre-bid should be implemented, if approved.
- 10. The Contractor in the Technical bid document specifically should provide details of the quality/type of material proposed to be used, operating costs involved and execution capabilities to meet the requirement of this specific project. In proof of the same, the Contractor should include complete details of a minimum of 2 projects executed of similar nature of work for an area in excess of 3000 Sq. ft and one project work executed amounting to Rs. 50 lakhs and above.
- 11. The bidder should have Karnataka Registration of GST and an office in Bengaluru.
- 12. Bid should be complete and covering the entire scope of job and should confirm to the bidders instructions and terms & conditions indicated in the bid documents. Incomplete and non-confirming bids will be rejected outright.
- 13. The bidder should have executed similar nature of work in Bengaluru.
- 14. The Bidder should not have been blacklisted by any Government offices in Karnataka due to non-performance of similar nature of contract work.
- 15. No Joint Venture/consortium is allowed to participate in the bid process.
- 16. INCOME TAX DEPARTMENT, BENGALURU may consider relaxation of any of the norms mentioned above if the bidders have exemplary previous record on quality of service from the three existing customers of it. This is subject to actual verification of the credentials.
- 17. The Department reserves the right to reject any bid without assigning any reasons thereof, in the interest of the work.
- 18. The bidder shall submit 5% of the total bid amounts as security deposit by way of Demand Draft drawn in favor of the ZAO, CBDT, Bengaluru along with the tender.
- 19. The Bid document is not transferable. Each bidder shall submit only one bid as per scope of work. No bidder shall have any cause of action or claim against INCOME TAX DEPARTMENT, Bengaluru, for rejection of his bid.

- 20. Any deviation from the clauses hidden/intentional/unintentional shall be considered as contravention of the clauses of Bid document and same shall also be grounds of rejection.
- 21. The Bid documents submitted should be signed and stamped by the authorized signatory of the organization on each page of the documents which are serially numbered [both technical and financial], the failure to do so will be treated as non-fulfillment of the Bid conditions and the bid shall be summarily rejected.

#### **WEST WING**

- b. Providing modular workstations with seating alignments (6+2), 3 drawer pedestal along with cable & wire manager conduit provision, Keyboard stand for the staff.
- c. Upgrading the lounge by providing 10-single seated sofas for visitors.
- d. Wall to wall Storage cabinets for two chambers.
- e. Re-doing of glass partition with plywood and glass pillars.

## TERMS AND CONDITIONS

- 2. 'Contractee' shall mean Commissioner of Income-tax (Exemptions), Bengaluru.
- 'Work Contract' shall mean the creation of work station, face lift of reception counter and wooden storage cabinets at 6<sup>th</sup> Floor, East & West Wing, Unity Building Annexe, P Kalinga Rao Road, Bengaluru – 560027.
- 4. 'Entity' in this document shall mean a Proprietary concern, partnership firm, LLP or a Company registered and incorporated under the Companies Act, 2013.
- The Contractor shall bear all costs associated with the preparation and submission of its bid. The contractee will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- 6. The Contractor shall quote the rates in the bid for the proposed work in the prescribed Performa alongwith the plan for carrying out the said work. viz., seating arrangement, and placement of workstations, visitors waiting area for both east and west wings and face-lifting of tappal counter for East wing and face lifting of entrance area and Wall to wall Storage cabinets for two chambers in West wing etc., All the columns in the Performa should be mandatorily filled and the contractor should mention rates separately for each work.
- 7. The Contractor should submit Pre-qualification Bid, Technical and Financial Bid separately. All the bids should be submitted in separate sealed covers. An acknowledgement for submission of bids may be obtained from Income-tax Officer(Hq)(Exemptions), O/o Commissioner of Income tax(Exemptions), Bengaluru on submission of bid.
- 8. The rates quoted in the bid should be inclusive of all taxes, including labour and other miscellaneous costs etc.,
- 9. The work shall commence immediately after the issuance of the letter of intent or work contract whichever is earlier and the Contractor should complete the work within 50 days of the awarding of the work contract by abiding the terms and conditions. Incometax Department will Forfeiture the EMD in the event of non completion/cancelation of contract by Bidder due to non meeting of the obligations
- 10. No escalations of costs on any of the items or statutory levies will be entertained. Prices shall be fixed till the end of the contract.
- 11. The Contractee reserves the right of accepting the whole or any part of the quotation received and the contractor shall be bound to perform the same at the rates quoted.

- 12. The work shall be carried out under the direction and supervision of the office of the Commissioner of Income tax (Exemptions), Bengaluru. The work shall comply with the specifications, Drawings and other contract documents as specified and accepted in the Technical bid and Financial bid.
- 13. The contractee decision with regard to the quality of the material and workmanship will be final and binding. Any material rejected by the Contractee shall be immediately removed by the Contractor and replaced by material of acceptable and specified quality and standards.
